

Safety information for visitors to CHEMPARK

Traffic rules:




Maximum speed 30 km/h.



Right before left.

Rail traffic has priority!



Compulsory wearing of seat belts for all occupants.

General rules of conduct:



Prohibition of alcohol and intoxicants

The bringing in and consumption of alcoholic beverages and intoxicants is prohibited. No one may enter CHEMPARK under the influence of alcohol or intoxicants.



Smoking ban

Smoking is prohibited throughout CHEMPARK. Smoking is only permitted in specially designated areas. The smoking ban also applies inside vehicles.

Prohibition of photography and filming

Photography and filming with cameras, cell phones, tablets or other devices is prohibited in the entire area of CHEMPARK. If you wish to take a photograph, please contact the relevant contact person at the site or CHEMPARK Security.



Access for unauthorized persons is prohibited!

No staying in CHEMPARK at night

Staying overnight in vehicles, driver's cabs or other facilities in CHEMPARK is prohibited! Vehicles must leave the site at night to wait or stay overnight!



Follow site security instructions

Vehicle and personnel checks are carried out. The instructions of CHEMPARK Security must be followed!

Observe barriers

Do not enter marked and/or cordoned-off areas. Danger to life!



While driving: Telephone calls only with hands-free system.



Smoking ban also inside vehicles.



Vehicles parked in violation of traffic regulations will be towed away for a fee.



Prohibition of (e-)skateboards, rollerblades, (e-)scooters, (e-)kickboards, motorized two-wheelers.



Video surveillance

Video surveillance areas are marked. The outer boundaries of the CHEMPARK are under video surveillance.



Prohibition of electrical equipment and ignition devices in explosion protection areas

Areas subject to explosion hazards (Ex areas) are marked accordingly. Electronic devices such as laptops or cell phones, smartwatches, etc. are generally prohibited in Ex areas. This also applies to electrical devices when switched off and to cell phones in non-Ex design.



It is forbidden to carry matches and lighters in buildings and areas marked Ex.



It is also prohibited to enter Ex areas by vehicle.

Obligation to carry identification

ID cards must be carried on the entire premises. The CHEMPARK ID or day pass must be worn openly and visibly on the clothing.

Prohibition of animals

Animals are not allowed on the premises. You should also not touch any animals in CHEMPARK as there is a risk of injury or infection.



Hazardous substances present! Keep your distance, do not touch



Driving on track areas with ballast prohibited



Safety information for visitors to CHEMPARK

Always report emergency/accident/traffic accident.

Notify the Safety Center (Sicherheitszentrale) immediately if you notice the following: medical emergency, accident, fire, pollution, traffic accident, or other claim. Remain on the scene. If necessary, notify the emergency services.

Please save the emergency number in your cell phone before your stay at CHEMPARK.

Behavior during malfunctions and in the event of a fault:

- 📕 Keep calm.
- Stay away from the site of the malfunction.
- In the car or buildings: Close windows and doors.
- In the car: turn off ventilation.
- Do not walk or drive through leaked liquids, unknown solids, dusts, or escaping gas clouds and fire smoke or through restricted areas.
- Do not enter or drive in cordoned-off areas. Do not interfere with rescue operations.
- In case of danger or when audible danger signals sound (beep with periodic pause or rapidly rising and falling signal): Leave the danger area, if possible across the direction of the wind, or seek the nearest enclosed building and proceed to the reporting point/measuring station for information on further behavioral measures. Leave endangered area quickly with vehicles without endangering others; park vehicles so that escape routes are not obstructed.
- Within plants, facilities and buildings, follow the instructions of the operating personnel.
 - In the event of irregularities, e.g. leaking liquids or gas clouds, call the safety center.
