Special turnstile activation for employees of external companies with assignments on weekends, public holidays and nights (validity period: 1 year)

In general: **All fields not marked with „optional“ are mandatory! If the information is incomplete, you will not be admitted to CHEMPARK.**

CHEMPARK ID cards issued to employees of external companies are only activated on weekdays from 6:00 to 20:00. **If regular jobs are to be carried out by external companies on weekends, public holidays or at night (between 8:00 p.m. and 6:00 a.m.), activation must be requested using this form.**

The company placing the order at CHEMPARK must be listed here.

The company that carries out the job on site at CHEMPARK is listed here - even if it is acting as a subcontractor for another company that was originally awarded the job.

Staying at CHEMPARK outside the regular weekday time window is only permitted at the location specified here. The direct route to the place of work within CHEMPARK must be used without detours. This does not include visits to the social areas and canteens.“
