

How to fill in the form ...

Check-in form for deliverers/collectors with pre-registration

In general: All fields not marked with „optional“ are mandatory! If the information is incomplete, you will not be admitted to CHEMPARK.

The type of service at CHEMPARK must be specified.

The person in charge of the order at CHEMPARK must sign so that the day pass can be prepared and issued without telephone legitimation when the driver arrives. Without signature, the process is the same as the unannounced check-in process. Longer waiting times must be expected.

Attention: The driver must be able to present a valid official identification document for identification and, if applicable, a residence permit plus work permit at the gate.

Do you also need a co-driver to enter CHEMPARK? Then it is mandatory to fill out a second check-in form! Here, too, an identification document is required for identification purposes. **Children and animals are not allowed.**

Please note: The information is not optional! If a trailer/semitrailer is present or a container/dumpster is carried, the corresponding license plate number or no. must be indicated. The weight specifications refer to the permissible total weight of the vehicle.

Cargo intended for CHEMPARK operation must be described here and specified in quantity.

Additional cargo is cargo that is taken to CHEMPARK and also exported again because it is intended for another recipient. It must also be described and specified in quantity. This is because **additional cargo not specified on entry cannot be exported from the CHEMPARK until the ownership situation has been clarified beyond doubt.**

If only one tablet or laptop is being taken along, it is sufficient to note the serial number here. If tools or more extensive IT equipment are to be taken into CHEMPARK, this must be registered separately. Tools and IT equipment may only be taken out of CHEMPARK if the ownership situation has been clarified beyond doubt.

The driver signs the form only after having read the safety instructions on www.lieferung.chempark.de or at the gate.
